Identification of Tree(s) and Description of Works

Please identify the tree(s) and provide a full and clear specification of the works you want to carry out

All trees T1 to T5 - crown lift to give 5m above ground clearance. This is to allow reasonable enjoyment of the gardens at this property, and to enable and encourage growth of younger trees and shrubs located underneath existing trees. Additionally, the work are to improve the amenity value of the trees by enhancing their inherent aesthetic attributes along with improving the visual relationship between the trees and their setting.

I was also asked to inspect T5 after fruiting bodies of Meripilus were found nearby - the distribution of the fruiting bodies suggests that the infection is not centred on T5 but on another nearby location where it is understood that a large tree collapsed in the past. Additionally, the vigour and vitality of T5 is good, and this does not suggest a significant root disfunction. The tree owner has therefore been advised that the observed Meriplius infection is not likely to be associated with T5, but that they should be vigilant in monitoring the tree into the future for any changes to the patterns of Meripilus fruiting body locations or tree condition.

Two new trees are also to be planted - these being a nursery standard Swedish birch and a red Norway maple. These are to be planted and maintained in accordance with BS8545.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

Sketch plan requirements

Your plan needs to show the precise location of the tree(s) in relation to nearby property/roads/boundaries. It should, therefore:

- indicate the main features of the site where the tree(s) stand and its surroundings; in particular, you should:
 - mark and name surrounding roads
 - sketch in buildings, including adjoining properties
 - add house numbers or names
- mark the position of the tree(s) to which you want to carry out work and identify them by the number shown in the Tree Preservation Order where possible; if you use a different number, please make sure that this can be matched with your description of the tree(s)
- if there are many trees on the site, make clear which tree(s) are included in this application by:
 - marking all trees on the plan, but only numbering those to which you want to carry out work
 - showing the approximate distance between the application tree(s) and buildings
 - adding other relevant features on the site (e.g. greenhouse, paths)

If it is impossible to identify the tree(s) accurately on the plan (e.g. because they are part of a woodland or group of trees), please identify their approximate location on the plan and provide details of how the tree(s) are marked on site (e.g. high visibility tape, tree tags, paint, etc); trees must not be marked by scarring or cutting into the bark.
