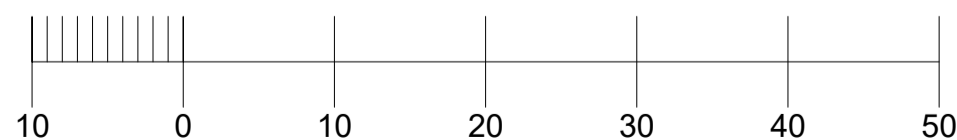


1 Existing Location Plan

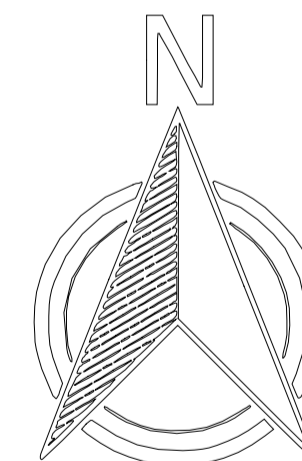
