Identification of Tree(s) and Description of Works

Please identify the tree(s) and provide a full and clear specification of the works you want to carry out

The tree is located in the center top of the garden which is over half an acre big. I think it is a sycamore tree. It is highlighted on the plan in the middle.

the main middle part of the tree came down on Sunday night the 29th March 2026, destroying a cherry tree, damaging a wall and nearly fell on a works vehicle. My tree surgeon came out and assessed the damaged and due to the location, the proximity of the tree to vehicles and buildings. Due to the damage done to the tree he has indicated that the safest option would be to remove as it is now unsafe due to this damage already sustained by said tree, and he considers it now unsafe.

This tree is in the centre of a very well used garden for both vehicles and for my grandchildren to play and for me to do gardening.

I now feel very unsafe near this tree and you can see it is severely damaged in a way it cannot repair and is exposed to disease. I am not prepared to take the chance of any more damage occurring and consider it a threat to life and damage to property and vehicles if any more limbs were to follow the same pattern as the other night, or if it is to fall completely.

As you can see, this tree is also growing at an acute angle leaving it more susceptible to falling,

I requested a visit immediately from the TPO officer who did arrive promptly to enable him to have discussions with my tree surgeon. My tree Surgeon advised in clear terms he considered the tree dangerous and advised felling as soon as possible. this i am requesting to do .

I have been advised by Joe from the tree department that he has sent an email outlining what he was told and what he saw on his visit.

I understand there is a long process normally for these matters but i do request an urgent response due to the urgent nature now of this tree being unsafe and if you could contact me asap on 07931721084.

I am now having to restrict access to my garden area for fear of this tree and am dreading any wind or adverse weather.

I now feel i have done all i can to get permission and and I placing responsibility for any further damage directly at the door of the planning office if this is not dealt with promptly and a swift decision made to fell this tree.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

 - add house numbers or names
- mark the position of the tree(s) to which you want to carry out work and identify them by the number shown in the Tree Preservation Order where possible; if you use a different number, please make sure that this can be matched with your description of the tree(s)
- if there are many trees on the site, make clear which tree(s) are included in this application by:
 - marking all trees on the plan, but only numbering those to which you want to carry out work
 - showing the approximate distance between the application tree(s) and buildings
 - adding other relevant features on the site (e.g. greenhouse, paths)

If it is impossible to identify the tree(s) accurately on the plan (e.g. because they are part of a woodland or group of trees), please identify their approximate location on the plan and provide details of how the tree(s) are marked on site (e.g. high visibility tape, tree tags, paint, etc); trees must not be marked by scarring or cutting into the bark.
