I am writing to formally request permission to remove a tree with a Tree Preservation Order (TPO) agreement on it in our carpark. The tree is currently hindering our ability to expand our parking area to accommodate the rapid growth of our company. The tree has never posed an issue in the past, even during a recent kitchen extension. However, due to our company's expansion, we urgently need to extend the carpark to create two additional parking spaces. This expansion is necessary to meet the increased demand for parking spaces as we are expanding our office team through local recruitment.

The removal of the tree would have several benefits for both our company and the local community. It would prevent our employees from parking on the street, which has caused issues with our neighbours. It would also increase light levels in nearby houses, as the tree branches currently block sunlight and result in darkened homes during the summer months.

Additionally removing the tree would eliminate potential issues with local drains and prevent damage to our employees' cars caused by sap constantly landing on them.

We understand the importance of preserving trees and the environment, and we assure you that we will mitigate the impact of the tree removal by planting new trees in the community in a more suitable location.

We have recently sent a letter out to the neighbouring homes advising of our intention to request this, I have attached a copy of the letter that we sent.

I hope this request can be agreed as this would not only help us in growing as a company but have a positive impact on the local community as well

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

- indicate the main features of the site where the tree(s) stand and its surroundings; in particular, you should:
 - mark and name surrounding roads
 - sketch in buildings, including adjoining properties
 - add house numbers or names
- mark the position of the tree(s) to which you want to carry out work and identify them by the number shown in the Tree Preservation Order where possible; if you use a different number, please make sure that this can be matched with your description of the tree(s)
- if there are many trees on the site, make clear which tree(s) are included in this application by:
 - marking all trees on the plan, but only numbering those to which you want to carry out work
 - showing the approximate distance between the application tree(s) and buildings
 - adding other relevant features on the site (e.g. greenhouse, paths)

If it is impossible to identify the tree(s) accurately on the plan (e.g. because they are part of a woodland or group of trees), please identify their approximate location on the plan and provide details of how the tree(s) are marked on site (e.g. high visibility tape, tree tags, paint, etc); trees must not be marked by scarring or cutting into the bark.
