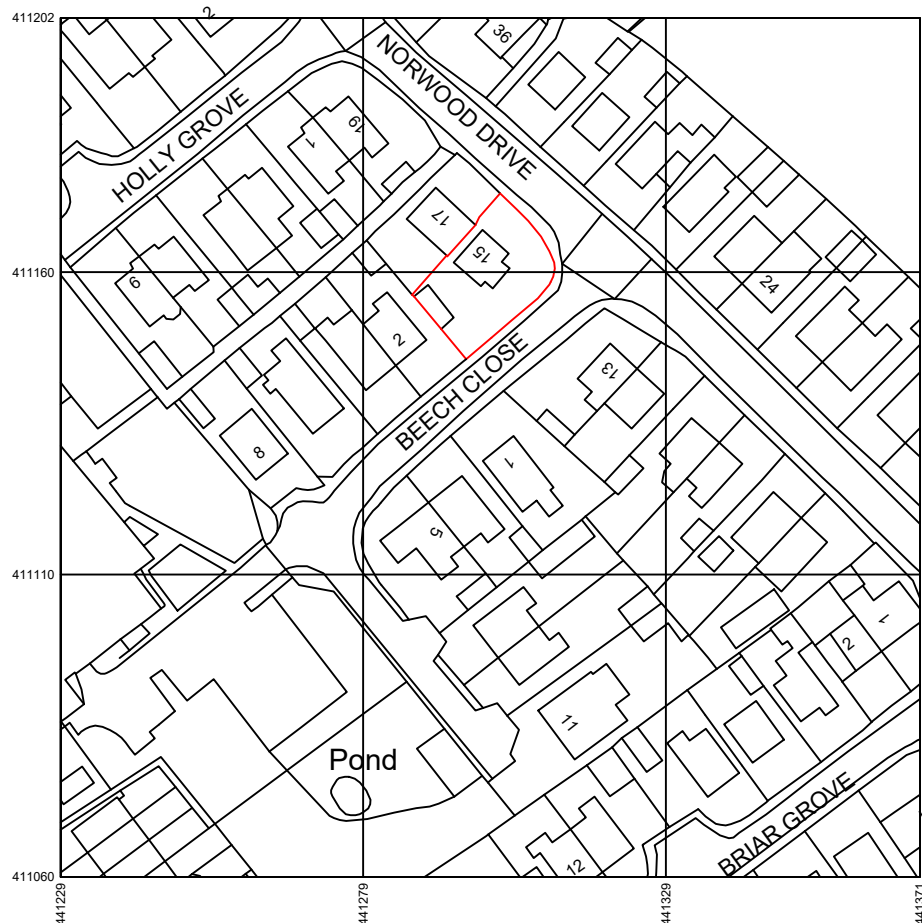

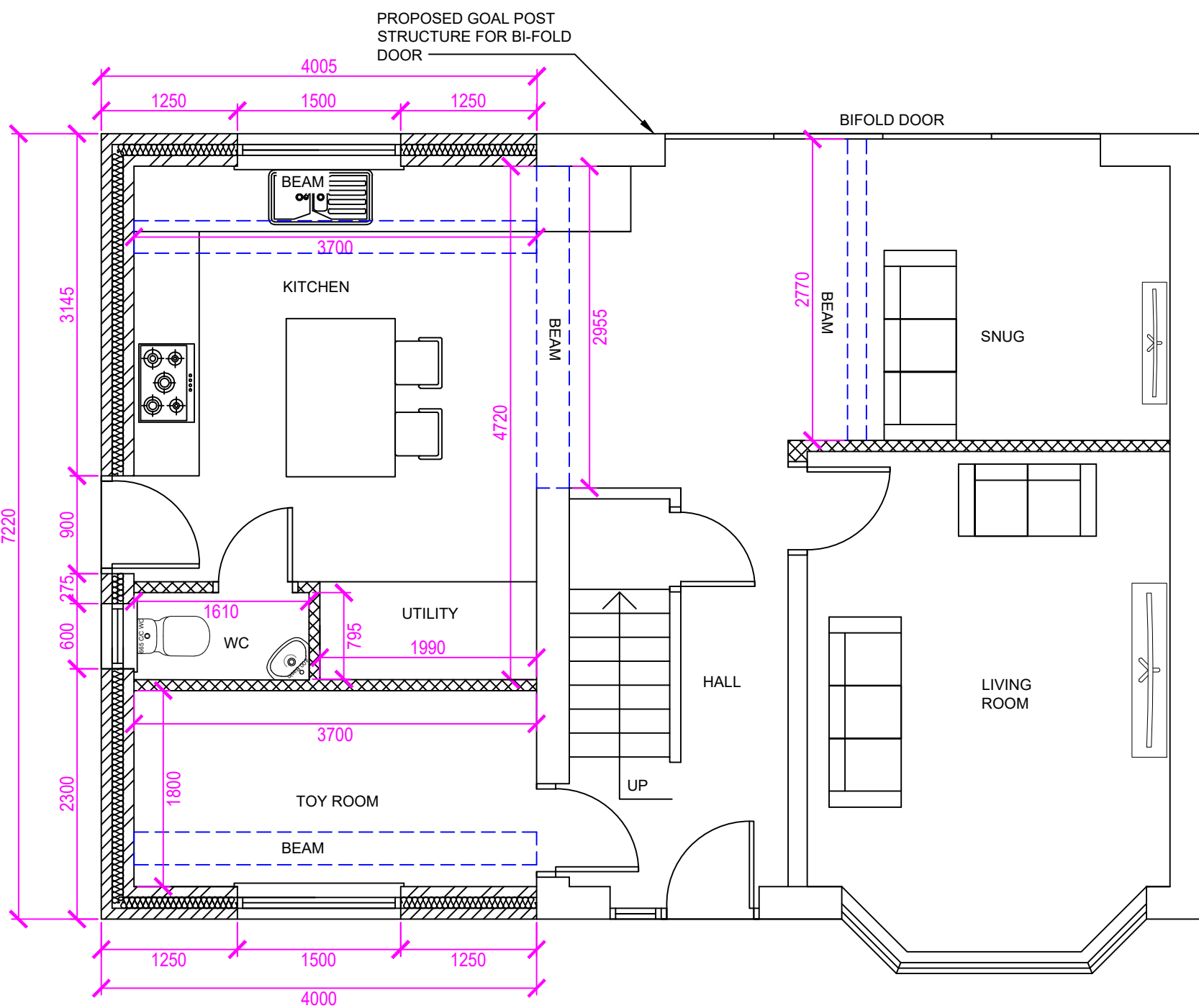
3 EXISTING GROUND FLOOR PLAN

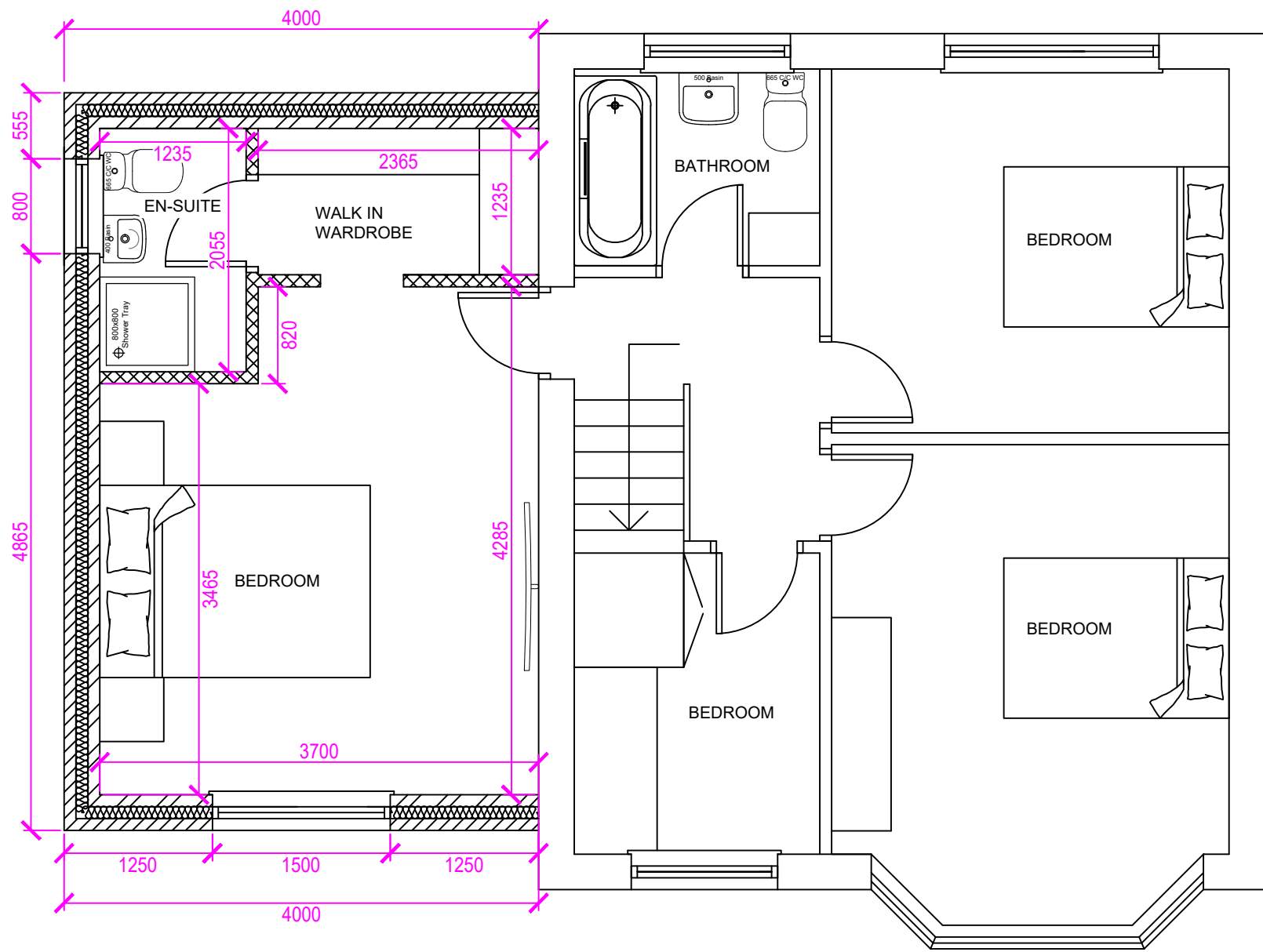
4 EXISTING FIRST FLOOR PLAN

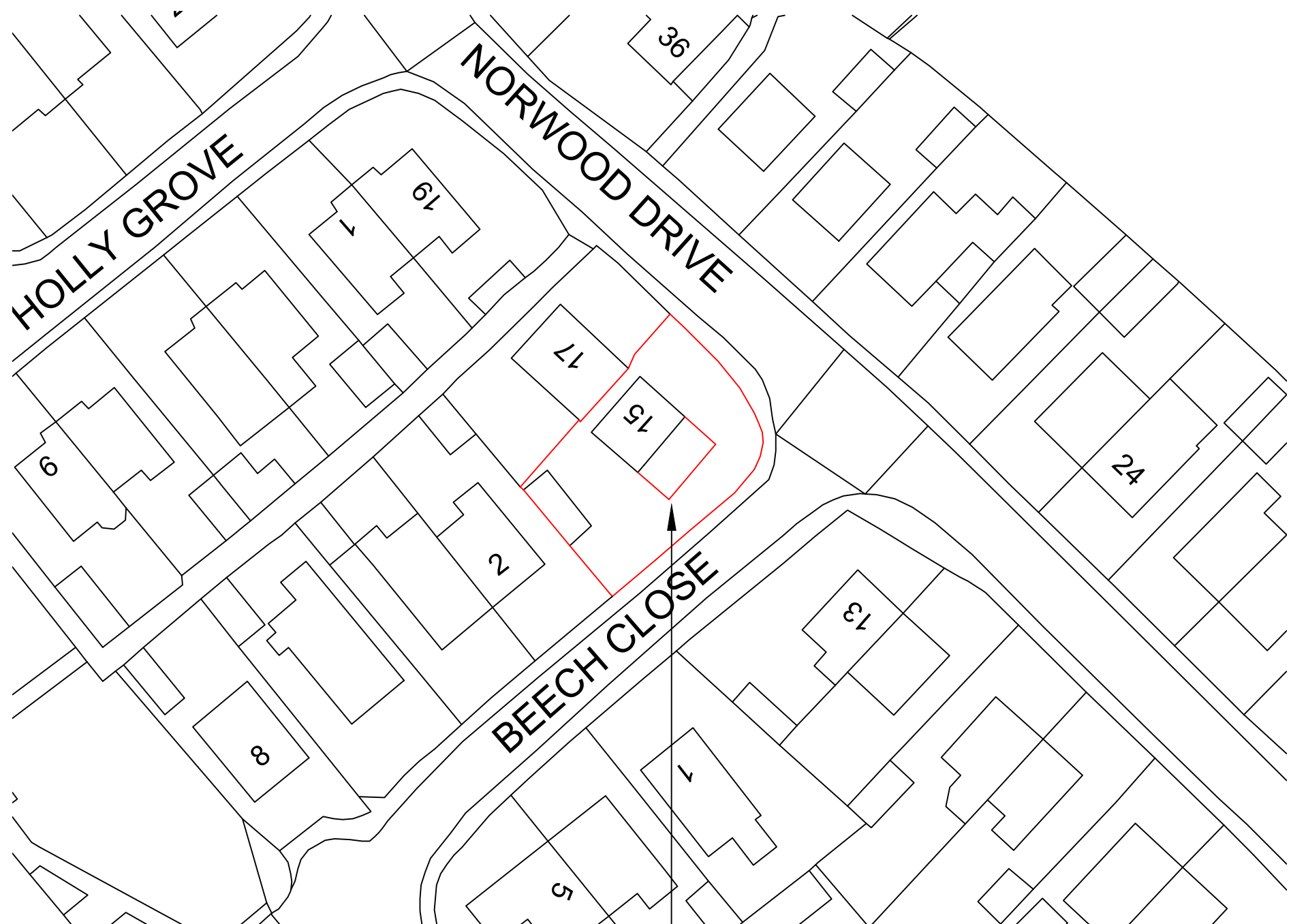
1 LOCATION PLAN
