Thank you for confirming the works relate to the southern fence. As the replacement fencing would both exceed 2-metres in height and exceed the height of the existing fencing planning permission would be required. As stated previously, this would require the submission of a full planning application form. I would expect this would be charged based upon site area where the fee would be £234 for each 0.1 hectare (or part thereof).
