Details of the pre-application advice received

The principle of development has the potential to prove acceptable. However, it must be clearly shown that the proposal will not amount to more than a doubling of the size of the original building, in accordance with national and local plan policies. At present, it is stated that the total floorspace would become approximately 387.5 square metres which would not amount to more than a doubling of the size of the original building. Nonetheless, it may be beneficial to assess whether any additional existing structures could be removed to enable the development of the proposal and to lessen the extent of any potential impact to the Green Belt.

There may be the potential to offer further improvements within any future scheme. Careful consideration should be given to the design of any future proposal to ensure that they appear subservient and sympathetic to the character of the existing building and wider street scene. The proposal should not give the appearance of the existing building being overdeveloped. A landscaping scheme to the south boundary line could offer improved screening and privacy of the enquiry site and could offer a buffer zone between the dwelling and the public realm of the highway.

Please note that the views and opinions in this letter do not constitute a formal response or decision of the Council in relation to any future planning application, but they will be treated as a material consideration in the determination of any future planning application for a period of two years.
