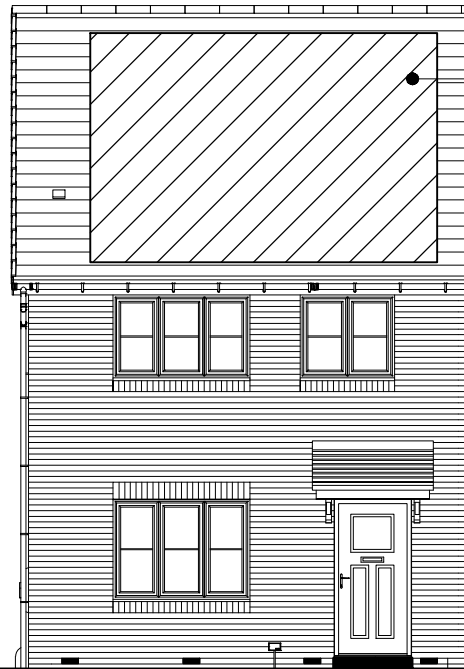

FRONT ELEVATION

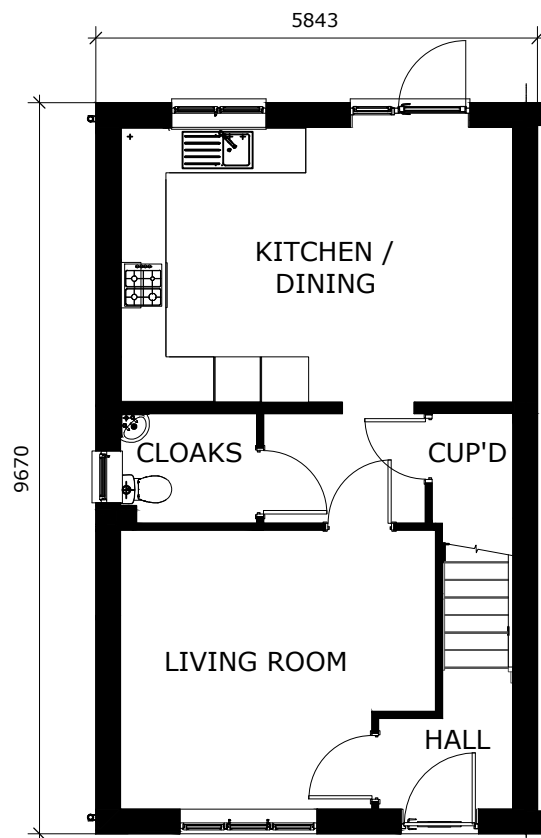


LEFT ELEVATION

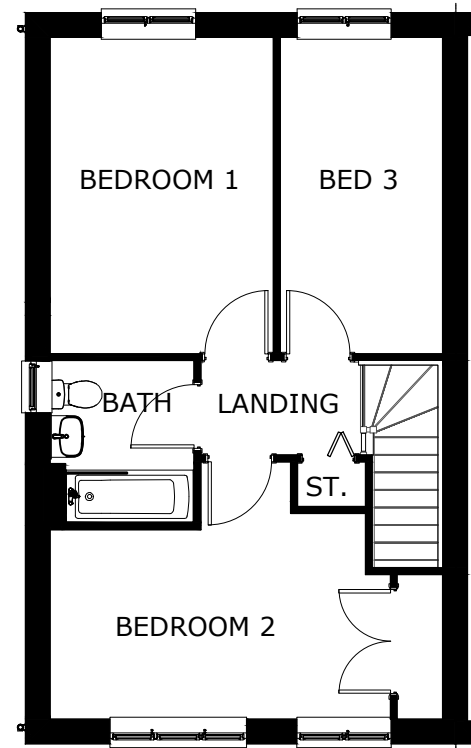

REAR ELEVATION



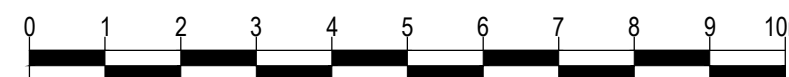
GROUND FLOOR PLAN
