POLLARDING OF CHERRY TREE TO 10 FEET.

The Granary is a Grade 2 listed barn, converted in 2003.

The barn is located adjacent to a small wood belonging to Huthwaite Hall Farm which is subject to a TPO.

There is a height differential between the wood and The Granary (the 'floor' of the wood is approximately level with the eaves of The Granary).

A large cherry tree at the edge of the wood has grown at an angle and is now overhanging the roof of The Granary - there is a small retaining wall however the tree has grown over this wall and is now a substantial height.

Mr Wayne Salter (Tree Surgeon - Salter Tree Services) has surveyed the site and advised that, as the tree continues to grow, there is an increasing risk that it could fall (due to the angle of growth / associated weight / relative instability of the retaining wall). If the tree did fall then, due to the proximity and angle of growth, it would fall directly onto the roof / gable end wall of The Granary.

Mr Salter has recommended pollarding of the cherry tree to a height of 10 feet.

The current owners of Huthwaite Hall Farm (The Executors of Kenneth Tinker), having spoken with them, have advised that they have no issue with the proposed work (subject to appropriate planning consent being approved).

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

- indicate the main features of the site where the tree(s) stand and its surroundings; in particular, you should:
 - mark and name surrounding roads
 - sketch in buildings, including adjoining properties
 - add house numbers or names
- mark the position of the tree(s) to which you want to carry out work and identify them by the number shown in the Tree Preservation Order where possible; if you use a different number, please make sure that this can be matched with your description of the tree(s)
- if there are many trees on the site, make clear which tree(s) are included in this application by:
 - marking all trees on the plan, but only numbering those to which you want to carry out work
 - showing the approximate distance between the application tree(s) and buildings
 - adding other relevant features on the site (e.g. greenhouse, paths)

If it is impossible to identify the tree(s) accurately on the plan (e.g. because they are part of a woodland or group of trees), please identify their approximate location on the plan and provide details of how the tree(s) are marked on site (e.g. high visibility tape, tree tags, paint, etc); trees must not be marked by scarring or cutting into the bark.
