TOWN AND COUNTRY PLANNING (TREE PRESERVATION ORDER) REGULATIONS 1969

In pursuance of its powers under the above-mentioned Act and Regulations the Barnsley Metropolitan Borough Council as the Local Planning Authority hereby **grants consent** for the proposals the subject of the plan(s) and application registered by the Council on the 29/09/2023 and therein described as:-

Reduce Sycamore tree back from fence by 6 foot within TPO 6/1998

9 Mulberry Close, Goldthorpe, Rotherham, S63 9LB.

The approval is subject on compliance with the following conditions:

- The proposed tree works should be completed within 2 years of the date of this consent. Reason: To ensure that the works accord with good arboricultural practice.
- Not less than five working days notice of the date of the proposed work shall be given to the Local Planning Authority and Barnsley Council Parks Services and their Tree Inspections and Maintenance Manager who own and manage the tree and the tree surgery shall be carried out to the standards set out in BS3998.

Reason: To ensure the work accords with good arboricultural practice.



Informative(s)

Pursuant to article 35 (2) of the Town and Country Planning (Development Management Procedure) Order 2015 (as amended), the Local Planning Authority have, where possible, made a preapplication advice service available, and otherwise actively engaged with the applicant in dealing with the application in a positive and proactive manner.

Before proceeding with the notified works, you should ensure that you have the permission of the owner and in this instance the Council Tree Inspection and Maintenance Manager and where required comply with the assurances they require and provide the information they need in order to grant access to undertake the works. You will also need to ensure you comply with all other relevant legislation, for example it is an offence to disturb nesting birds, and bat roosts.

Please be aware that the Council monitors construction sites and open land within the vicinity of such sites in an attempt to prevent fly tipping (i.e. unauthorised deposit of waste on land), which is illegal under the Environmental Protection Act 1990. The penalties for fly-tipping can include:

- a fine of up to £50,000 and
- up to six months imprisonment on conviction.

Therefore, if necessary, please ensure that all demolition waste and waste associated with the construction of any development is disposed of via approved methods and that documents are retained to prove this.
