Details of the pre-application advice received

Looking at this enquiry, it has jumped significantly from 4 (as approved) to 10 dwellings. Having looked at the site plan, there are a few concerns with this and I have a few queries:

1. Plot 10 looks to be too close to the existing dwelling 'Tulloch'. A separation distance of 12m should be retained between habitable rooms and blank gables, a 8.5m separation distance is retained between plot 10 and Tulloch which detrimentally affects the outlook of the existing dwelling. Plot 10 also does not meet separation distances to the rear boundary line (c.8m when 10m is required).
2. Plot 1 is 12m from the neighbouring properties at 2 and 4 Oak Road. The dwelling is directly to the South of these properties and therefore will have a greater overshadowing impact. 12m is sufficient distance to indicate that the overshadowing impact will not be on the windows of these properties, but I would consider that plot 1 has a significant overshadowing impact on these respective garden areas. I appreciate that buffer landscaping is proposed to the North of Plot 1, adjacent to the rear boundary lines of 2 and 4 Oak Road. Generally, additional soft landscaping would be welcomed but in this case, it could be counter-intuitive as it would result in further overshadowing.
3. The plans show that the access road is 'a private road', however, developments with 5+ dwellings require the road to be brought up to an adoptable standard. The design of the streets in the development must comply with guiding principles and technical guidance in the South Yorkshire Residential Design Guide (SYRDG) - <https://www.barnsley.gov.uk/media/4657/eb131-south-yorkshire-residential-guide.pdf>. This includes appropriate road width, visibility, turning areas, emergency vehicle access, signs, lighting, drainage, street furniture and speed. Tracking will be required to support any forthcoming application which shows that a refuse vehicle and a large car can safely enter and leave the site in forward gear. There is also no information as to how the existing driveway serving Tulloch will be affected – will this property still access the site from Oak Road? See full response from colleagues in Highways.
4. Parking – the development shows 2 parking space per dwelling which is in compliance with the Parking SPD. However, 1 visitor space per 4 dwellings should be included. Therefore, there is a shortfall of 2 spaces based on the current plan.

I've also attached responses from other consulted colleagues in the Council (Ecology, Drainage and Pollution Control) who have all requested further information should an application be submitted.

I think generally, we will definitely need a reduction in the number of dwellings here (at least 2 to reduce the impact on the existing neighbours) and the above points need clarifying please. Happy to have a chat on the phone, however I break up tomorrow at 12 and will return on 3rd January.
