Details of the pre-application advice received

I would suggest that the proposals in principle would appear to be reasonable, in keeping with the character of the dwelling, with particularly the conservatory roof being an improvement, and the impact upon the openness of the Green belt would be limited. If progressing towards an application, I would suggest providing as much information as possible about the history of the site (if known) and any mitigation for the requirement for extending the dwelling. If employing a agent or architect. Whilst we cannot recommend anybody specific, somebody with knowledge or experience of the Barnsley's Local Plan and supporting policies would be beneficial to maximise the potential for approval with requirements for amendments to meet local policy requirements. Finally although my personal (professional) opinion would be that I am reasonably optimistic about the proposal, without a full and in-depth knowledge of the proposal and site history, I would not be able to offer a definitive answer to whether a planning application would or would not be granted.
