Description

The property is currently classed as a dwelling house covering 29 Agnes Road but with the first floor and loft area extending over the groundfloor commercial property at 31 Agnes Road and also includes a rear yard with secure parking for up to 4 vehicles and bin storage accessed off Spring Street. The current internal layout of 29 Agnes Road is unusual and non-standard, it is not configured internally as a traditional family home and the layout does not lend itself for use as a family home as it is compartmentalised for use by multi-tenants with bedrooms and common facilities. The property also benefits from an existing interim HMO Licence granted this year by Barnsley Council Safer Neighbourhood Service on 22 April 2025 for an initial period of 12 months.

The proposed planning application is for Retrospective Change of Use, commencing 22 April 2025 as per current HMO Licence, from existing Dwelling House (C3) to a House of Multiple Occupation (C4). There are no proposed internal changes associated with this application as the property has already been inspected and assessed by the Local Licencing Authority and found to be compliant with all the requirements for use as an HMO to accommodate a maximum of 5 persons forming a maximum of 5 households, as per the granted licencing conditions. Further, if this application for change of use to C4 is granted, then the Licencing Authority will extend the existing licence to its full term of 5 years.
