The existing air-cooled chillers and equipment on the roof are approaching the end of life and HSBC is seeking to remove them and migrate the cooling load onto a different system. The chiller migration scheme aims to transfer the existing air-cooled chilled water load onto the existing water-cooled system. Remove the existing air-cooled chiller systems from the roof and replace them with two smaller air-cooled units to assist with secondary cooling. The existing roof gantry structure will then be decommissioned and replaced with a new purpose-built structure to cover the area throughout routine maintenance work.
