Oak - Removal of select branches and dead wood, to improve overall health of tree. Uneven and twisted growth, compensating for uneven crown weight distribution. Correct previous improper pruning by removing dead wood. Clear branches to allow access for telecoms. Work will be carried out with consideration for the health and future safety of the tree, to preserve it.
