We propose a change of use for this building. It is currently a HMO for six occupants and we propose to increase this to nine occupants (+3). With regards to the new floor plan, bedrooms 1 and 2 (lower ground floor, front and back) and bedroom 3 (ground floor, front, left) are proposed to accommodate a maximum of two occupants each, instead of one occupant. Bedrooms 4, 5, 6, 7 and 8 will be suitable for single occupancy. Works will be carried out as part of the internal property renovation, which will involve adding ensuite bathrooms to rooms 1, 2, 3, 4 and 6. An off-suite will be added to bedroom 5. Bedrooms 7 and 8 will continue to share the one bathroom. There are no external works to the property. On this basis, the property is deemed suitable as a 9-person HMO (Suis Generis).
