The upper portion of the western wall within the west gatehouse at Monk Bretton Priory is currently at risk of collapse. The proposals comprise: the erection of hoardings around the wall (a public footpath runs adjacent to the wall and will be closed off within the hoardings - a footpath diversion is already in place); the recording of the wall; the dismantling of the wall to make the area safe, storing the stone inside the hoarding compound; rebuilding the wall using the historic stone.

Details of the pre-application advice received

Tony advised that the proposals were favourable and would be important in improving this area of the site and making it safe. He viewed pre-application advice provided by the Historic England Inspector of Ancient Monuments, Andrew Burn, and noted the recommendations Historic England had made. The intention is to dismantle and then rebuild the wall, but the works will be phased for funding purposes: phase 1 will include dismantling, while phase 2 will involve rebuilding. The rebuilding will include adding interpretation to the wall to communicate its historic significance, but the exact nature of the rebuilding has not yet been finalised at the point of application. Tony advised that any planning permission could be conditioned so as to allow for detailed rebuilding plans to be submitted ahead of the second phase.
