Horse Chestnut (T2) - dead stab to reduce to monolith (around 3m) to make safe
Group of trees: Willow, Ash, Alder, Birch, Sycamore, Horse Chestnut, Elm, Beech to Crown lift to 5.2m over highway. Remove any self set small diameter (under 150mm DBH) trees.
