T6 oak tree requiring a crown lift to 8 metres. Removing primarily the lowest limb at 2.5 metres to create more space between the ground level and allow light to penetrate to the ground. Remove the over extended lateral limb coming off the second branch up which is around 8 metres up. The is to create more light and balance.

T6 - Crown cleaning to remove the excessive dead wood

T6 - crown reduction of 20% primarily to the branches which are over hanging the guttering and roof of the house.

T7 crown cleaning
