## Identification of Tree(s) and Description of Works

Please identify the tree(s) and provide a full and clear specification of the works you want to carry out

T1- carry out selective tip reduction of the height of the tree and of branches on the north and northwest sides by 0.5m to 1m, to reduce "lion-tail"-like structured branches with wounding at the unions. Wounding is present at these unions following branch failures on 23rd August 2024. The tree is growing as part of a group of 4 trees and is the edge tree.

T4- crown lift to remove 1 extending limb on the northeast side @ 4m, for clearance over neighbouring garage, as it is beginning to become over-extending over neighbouring garage.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

  - o marking all trees on the plan, but only numbering those to which you want to carry out work
  - o showing the approximate distance between the application tree(s) and buildings
  - o adding other relevant features on the site (e.g. greenhouse, paths)
