Details of the pre-application advice received

I refer to your enquiry relating to applying for a Take away at 1 Garden Street at Darfield.

I have received the following comments re this matter:

Highways

The enquiry site is located within the "commercial" area of the village. Garden Street benefits from waiting and loading restrictions in the form of double yellow lines. There is also a pedestrian crossing outside the property. There is no off-street parking at the property and no scope to provide any. However, there is some parking available at the end of Snape Hill Road, adjacent to its junction with Garden Street.

It is considered that it would be difficult to sustain a reason for refusal at a subsequent appeal. Therefore, it is not wished to raise highway objections.

Pollution Control

I have considered this proposal and have noted there are residential properties very close to the site.

There is a possibility of potential disturbance to these from noise from the take-away, in particular noise from any extraction systems etc – we would therefore need a noise assessment to demonstrate that this can be managed sufficiently.

Also, information relating to how odour from the kitchen will be managed would also be required.

Highways Drainage

I would confirm that in my opinion the details provided are sufficient and that I have no further observations to make with respect to land drainage.

In addition to the above I think it would be helpful to know if deliveries are a major element of the business and what the hours of operation would be.

There are often issues of litter and this should be addressed
