Reason for work - Substantial overhang and density to 39 Kendal Drive, Bolton upon Dearne - S63 8NJ which is blocking out natural light to both bungalow and garden.

Description of work.

Elm tree - Crown raise the canopy overhanging the property and garden, and thin crown by 20% to provide natural light to pass.
