Mr Kirkham agreed that age appeared to have got the better of the noticeboards, and they would certainly benefit from replacement. He advised it is permitted to install signage on religious premises whereby the size does not exceed 1.2 square metres in area. He added that if there is more than one entrance to the premises, on different road frontages, two signs of 1.2 square metres could be installed (both instances would exclude the posts). This application is being made as the proposed noticeboards exceed the stated size.
