e.g. Oak (T3) - fell because of excessive shading and low amenity value. Replant with one standard ash in same position.

Large sycamore tree (T1) in car park to rear of health clinic. When in leaf limits light to car park in that area. We have a problem with the volume of leaves falling in to carpark and creating a hazard for our patients falling, many of whom have lower limb injuries or use walking sticks and crutches. Some large branches are now overhanging the car park and we believe there is an increased risk to users of the clinic and to vehicles using the car park and we are concerned in case there are any high winds that they could also damage the building. We have had advice from a tree surgeon and he has recommended removing some of the large overhanging branches (see photo) and also a 10% crown thin and trim. It has been many years since any works has been carried out on this tree. We are unsure how to quantify the risk from the branches but just would like to minimise the risk if possible.
