Details of the pre-application advice received

Good afternoon Russel,

I would be supportive of this design change. Amending the opening position to allow the access immediately adjacent to the fireplace is net neutral in terms of fabric intervention or loss. The other internal changes to layout relate to modern structures in the modern extension so have little bearing on the listed building.

Regarding the amendment, for planning permission (0155) it seems fair to consider this a minor non-material – although I'd defer to Dan on that. In terms of the separate listed building consent (0158) we could vary the condition that relates to the approved plans. The operative part of the consent and title don't need to change so it's a tweak to condition 2 of the approved application:

2. The development hereby approved shall be carried out strictly in accordance with the plans (Nos 22046 -25 - P01 Site plan showing former mill pond extents (1:100), 22046 - 23 - P04, Elevations and 3D Views as Proposed (1:100), 22046 - 21 - P05, Ground Floor Plan and Site Layout as Proposed (1:50), 22046 - 22 - P02, Site Layout and Location Plan (1:200, 1:1250))
