I am emailing in relation to your planning enquiry at Redminster House. With previous approval for a similar garden outbuilding, subject to the usual consultations with neighbours and the parish council; with no objection form the conservation officer, there would be a very good chance of approval. Unfortunately, the opposite is true for the proposed extension. It appears that a garage with living accommodation above was previously withdrawn, with the garden room being approved separately afterwards. After reading the conservation officer's comments, which I have attached in full, illustrate their thoughts on that proposal, and on the current proposal.

From a planning perspective, without the consent of the conservation officer, it would be very difficult, for any extension to be approved.

Moving forward, whilst I would be able to help with any general planning enquires in relation to the proposal, for specific advice regarding the finer details of what would be required to make any application potentially acceptable by the conservation officer, would require a separate listing building/heritage pre-application. Unfortunately, there is a separate fee for this, but you would be dealing directly with the conservation officer. I am sure of the cost, but I do know it would be increasing (significantly) in April as it's a local fee rather than national fee, which will be rising by 3.8% in April.
