When we took on the lease for the building we changed the signage whilst retaining the framework of the signage that had been in position for approximately 10 years. We added a simple monochrome sign so as not to detract from the aesthetic of the building itself. There are two signs. The main sign is 1705m x 600mm and the secondary sign is approx. 500mm x 350mm. Both are black font on a chalk background.
