Details of the pre-application advice received

The proposal could be found acceptable should an application come forward. Although the site is designated Green Belt and has already exceeded the maximum floorspace increase permitted under Policy GB2, the increase is considered to be minimal and would service a covered BBQ area with open elevations as opposed to a garage or outbuilding. The proposal would therefore be likely to have a reduced impact and the removal of the Permitted Development rights allows continued control over further development of the site.
