Identification of Tree(s) and Description of Works

T18 - Oak - Dismantle tree to ground level due to subsidence damage to property of 16 Greenspring Avenue.

Install root barrier once T18 has been felled within rooting area of T17, T15 and T13 of 43/2009. Due to presence of gas main the only suitable position for a root barrier does not allow for the retention of T18. All other retention options have been considered and ruled out due to site constraints. Root barrier to follow edge of existing tarmac footpath. Site assessments indicate position of trench will be at a distance >6x the stem diameter of retained trees and is unlikely to affect stability and health of retained trees, where works are to one side only.

Replacement planting is to take place on a 3:1 ratio with like for like (*Quercus robur*) in the same location once root barriers have been installed.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

Your plan needs to show the precise location of the tree(s) in relation to nearby property/roads/boundaries. It should, therefore:

- indicate the main features of the site where the tree(s) stand and its surroundings; in particular, you should:
 - mark and name surrounding roads
 - sketch in buildings, including adjoining properties
 - add house numbers or names
- mark the position of the tree(s) to which you want to carry out work and identify them by the number shown in the Tree Preservation Order where possible; if you use a different number, please make sure that this can be matched with your description of the tree(s)
- if there are many trees on the site, make clear which tree(s) are included in this application by:
 - marking all trees on the plan, but only numbering those to which you want to carry out work
 - showing the approximate distance between the application tree(s) and buildings
 - adding other relevant features on the site (e.g. greenhouse, paths)
