The existing banking retaining wall had failed in a number of places and large area of the breeze block wall had fallen into the water course - River Don.

the proposal is to form a new retaining wall with sufficient drainage provision both through the ground to the rear of the new wall through the installation of gabion baskets and also through the inclusion of drainage points through the wall at the base to allow the surface water to flow into the water course.

The gabion baskets will then be dressed with natural stone which will be tied into the gabion baskets. (The wall was originally formed out of natural stone before breeze blocks were used circa 12 years ago when the wall was last repaired.)

The land to the rear of the existing wall is to be excavated to allow the installation of the gabion baskets and also provide additional support to the access drive to the residential property. The proposed new wall will be installed in the same location as the failed wall and the finished ground level above the gabion baskets will be at the same level as was previously.

There will be no alteration to the profile of the ground once these works have been completed to before the works and before the existing banking wall failed.

The Clients had/have made contact with the Environment Agency via phone and email and did not initially get a response but have now drawn up a scheme of works that are now seeking approval from Barnsley Planning Authority.

the Clients also tried to make contact with Barnsley Planning Department but unfortunately did not receive a response.

Works have started but have now stopped due to the issuing of a stop notice by Barnsley Council.
