e.g. Oak (T3) - fell because of excessive shading and low amenity value. Replant with one standard ash in same position.

Ash (T1) - Stem made safe under 5 day felling order due to dieback and large cavities from poor previous pruning to fell. Replant with weeping Lime
Ash (T2) - fell due to die back in canopy and bark failure on stem. Replant with Silver Birch
Ash (T3) - Deadwood and remove epicormic growth due to proximity with the house
Yew (T4) - fell due to poor form as original part of hedge which has been allowed to grow excessively. Replant with pyramidalis Hornbeam
