The Local Plan summary:-

In terms of the consultation responses, the following comments have been made:-

Pollution Control

Construction or remediation work comprising the use of plant, machinery or equipment, or deliveries of materials shall only take place between the hours of 0800 to 1800 Monday to Friday and 0900 to 1400 on Saturdays and at no time on Sundays or Bank Holidays

Reason: To reduce or remove adverse impacts on health and the quality of life, especially for people living and/or working nearby, in accordance with Local Plan Policy POLL1

Prior to any work commencing, the applicant shall submit to the Local Planning Authority for their approval a noise and dust management plan detailing how they will control noise and dust during construction. Once approved the applicant shall adhere to the noise and dust management plan at all times.

Reason: To reduce or remove adverse impacts on health and the quality of life, especially for people living and/or working nearby, in accordance with Local Plan Policy POLL1

Drainage

Culture and Visitor Economy

The Culture and Visitor Economy Services welcomes the elements included in the pre-app relating to green landscaping, lightly zoned meeting areas and use of different textures and patterns for hard landscaping. It is also positive to see that the market will have anchor points set up in a way that it can be a covered space for events for the community.

Highways

The access to this site is signalised and forms part of the Barnsley Road/Doncaster Road/High Street signalised junction in the centre of Goldthorpe. The proposed layout plan appears to indicate the intention to install bollards across the site access; this would only be acceptable if the signals were to be removed because the access was perhaps to be very infrequently used only for maintenance purposes for example. However, this is not the case and usage of the access will be more frequent which means the signals must be retained and as such the access must be designed accordingly with no physical restrictions and a stop line needs to be positioned where it can be picked up by the overhead signal detector. This will need to be accounted for in any design submitted as part of a full planning application.

Prior to the submission of an application, I would advise that the applicant make contact with the Councils' Traffic department so that the views of a Traffic Signals Engineer are sought at an early stage to allow a suitable access arrangement to be produced for submission.
