**3. Description of the Proposal**

Please describe the proposed development including any change of use:

The project is a renovation of a First Floor ward in the Woman and Childrens Block at the Hospital, to relocate the existing Third Floor Neonatal ward to the First Floor. This is due to the current ward becoming unsuitable for the volume of patients. The ward is undergoing of internal modifications, including the demolition of a large amount of walls and strip out of all existing fittings to be replaced with new partition walls and furniture.

One of the main modifications is the addition of a new link bridge connecting the ward to the lift lobby. This addition is essential as the current entrance to the ward is through the Birthing Suite which is completely unsuitable. The bridge goes through the internal courtyard of the block and is not visible from the outside of the block. For the bridge to be built it is necessary for the roof of the existing Ground Floor walkway through the courtyard to be modified to allow for the floor construction of the First Floor bridge.

The other external modification to the building is the addition of two small plant room structures on the Ground Floor roof. This roof area is adjacent to the new Neonatal ward, and one side of the ward looks out one to the roof. The plant room is necessary for the modifications to the ward and ducts from the structures enter the ward on this side of the building. To hide the ducts we are using a louvered screen.
