Oak trees directly behind properties on Calabria grove, causing much damage to gutterings, e blocking gutterings with leaves + grass growing, causing gutter joints to become loose, the cost to get these cleared, we have spent numerous pro

amounts of money to improve our garden with decking but due to the trees we find that the decking is constantly covered in leaves, moss and is being discoloured by sap + lack of daylight caused by the size of the trees behind.

The property windows are covered in sap, even when cleaned still feel sticky + appear smeared, the UPVC around the windows is beginning to discolour as a result of these issues, we have to sweep + clear our back garden daily just to maintain some kind of cleanliness our paving is constantly stained with bird droppings + mould from the lack of sunlight, we cannot grow plants as a result of being shaded daily.
