In this instance, we would recommend that planning consent would be required as it is a non-residential building. The fee for the application would be reasonably nominal as there would be no increase in the square footage of the building. It will more than likely fall under "Other operations" where the fee is based on site area, at a calculation of £298 for each 0.1 hectare (or part thereof)
