Details of the pre-application advice received

I've looked at the information that you have sent through, along with the information we had in our files. From our records and from what has been provided, it looks like the development proposed would effectively be a raised platform given that it's 2.2m higher (as stated on the enquiry form) than the ground to the side/ginnel area. The form states that the decking area would be 2.2m higher than the ginnel itself which would indicate to me that it is to be built off the wall. The raised decking area would be in very close proximity to the neighbours and, if the form is accurate, it would effectively be introducing a 4.2m wall/fence almost on the boundary line (2.2m + 2m boundary fence). The development would also be visible from the front through the ginnel/archway.

Given the above it is my opinion that the development would require planning permission. The proposal may raise issues of loss of amenity to neighbouring properties and there could also be visual amenity issues but it is difficult to tell exactly what the impact would be from the information we have at this stage. Going forward, if they do wish to pursue it, I would recommend that they would need to submit a planning application and they may benefit from talking with a planning agent or architect in order to get suitable plans drawn up which is what we will require in a formal planning application submission.
