We asked for some advice from a tree surgeon regarding cutting back the tree as we are worried about the amount of branches falling as we have 3 small children that play in the garden.

On his inspection he noted that the tree had been badly cut in the past leaving the tree open to disease.

We are happy to replace the tree with an appropriate tree but would need advice on the type of tree that is safe and will thrive in the area.
