The original Planning Application was designed as a bespoke Cinema for an operator who has subsequently been unable to progress with the proposals. The amended Application is to address changes to suit a new operator who is progressing with the project. The new Cinema operator would prefer to have more smaller seat cinemas to reflect the way Cinema use is changing hence the increase from 9-10 screens with effectively no change to overall occupant numbers. Cinema technology has developed since the original submission and this will now be a fully digital cinema without conventional projection rooms. This results in some minor dimensional changes to auditoria. The changes arise primarily from the change of Cinema operator and design development, the footprint and parking associated with the scheme are unaffected.
