## Identification of Tree(s) and Description of Works

T1 - Sycamore - Fell to ground level and treat stump  
T2 - Oak - Fell to ground level and treat stump

Pruning assessment completed to assess pruning options to abate nuisance (see supporting docs). Pruning to achieve required nuisance abatement would be significant and beyond what is appropriate, Removal and replacement planting is the preferred option.

It is proposed to replace with 6x trees, 3x Quercus robur and 3x Acer campestre to provide like for like native planting. 3x Acer campestre and 1x Quercus robur are proposed for replanting in the public open space where the required removals will take place. To avoid over planting this area and prevent future issues with damage to property, 2x Quercus robur are proposed for planting on the open space to the north of Keresforth Primary School.

  - mark and name surrounding roads
  - sketch in buildings, including adjoining properties
  - add house numbers or names
- mark the position of the tree(s) to which you want to carry out work and identify them by the number shown in the Tree Preservation Order where possible; if you use a different number, please make sure that this can be matched with your description of the tree(s)
- if there are many trees on the site, make clear which tree(s) are included in this application by:
  - marking all trees on the plan, but only numbering those to which you want to carry out work
  - showing the approximate distance between the application tree(s) and buildings
  - adding other relevant features on the site (e.g. greenhouse, paths)
