The proposed addition of solar panels to the property will enable us to reduce our reliance on fossil fuels. This will be an important improvement to our home helping with our energy needs to make it more sustainable and consistent with current policy for greener energy. The house currently relies on oil for central heating as no mains gas is available. In future when the current boiler needs replacing we will need to install a heat pump, as this will require other upgrades and increase electricity consumption the addition of solar will help offset running costs. We have spoken to the three neighbouring households who have all indicated their support for us to add solar to our roof. The house was originally a dairy barn it is built of mixed local bricks from the Hepworth site, and with an artificial slate roof. Prior to conversion as a dwelling it had ceased to be used as a barn and was for a time used as a recording studio by Def Leppard. The property was converted in 2006. The existing roof is made of dark grey artificial slates, the addition of black solar panels should not detract from the overall appearance of the house. The panels will have bird guards to prevent damage but these will also have the effect of neatening the appearance of the installation.
