The proposed development comprises minor works to existing building, including alterations to roof, additional windows, installation of AOV rooflights etc on previously developed land. The works do not result in the loss of any priority habitat, trees, hedgerows or ecologically significant features. Existing vegetation along the site frontage will be retained and managed, including trimming where necessary to maintain visibility splays, and will not be removed. The extent of any vegetation affected is negligible and the proposals include the retention and extension of grassed areas, providing a small enhancement to site amenity and biodiversity value. The development is therefore considered to fall within the de minimis exemption to the mandatory biodiversity net gain requirement.
