Application for Change of Use (C3 to C2)

Pockets of Peace Care Ltd proposes to convert this 4-bed detached property into supported accommodation for 2 care leavers (16-25 years). The C2 use will provide transitional support while maintaining the property's residential character.

Key Details:

No structural changes – retains all original features

Accommodation: 2 young person bedrooms, 1 staff room, office (3rd floor)

24/7 staffing (36-hour shift pattern)

Support includes: Life skills, education access, therapy, and keyworker sessions

Facilities: Large garden, open-plan living, walking distance to amenities

Operational Impact:

Parking: Max 1 staff vehicle (less than family occupancy)

Visits: Monthly social worker checks, occasional visits from other approved professionals

Safety: OFSTED-registered, individual risk assessments, 10:30pm curfew
