e.g. Oak (T3) - fell because of excessive shading and low amenity value. Replant with one standard ash in same position.

The trees are within the category 'Group of Trees' with the description 'Mixed Deciduous Woodland'. The Tree Group Reference Number is 'G6' and the TPO area reference number is '1'.

Proposed Rear Garden Tree Removal:

Holly (T1) - To be removed due to poor tree health and little visual merit to the existing garden.

Cherry (T2) - To be removed due to poor tree health and it's unhealthy appearance does not add visual merit to the existing garden.

Pine (T3) - To be removed due to its growth in close proximity to an oak tree and it's removal will help preserve the health of the oak tree.

Rear Garden Planting replacements: It is proposed that 10 new native deciduous trees will be planted throughout the rear garden to compensate for the removal of these 3 trees. Positions and sizes are illustrated on the proposed rear garden plan.

Proposed Front Garden Tree Removal:

Copper Beach (T4) - To be removed due to the roots causing structural damage to the adjacent boundary wall and close proximity to the main house structure.

Front Garden Planting replacements: It is proposed that 16 new native deciduous trees will be planted throughout the front garden to compensate the removal of this tree. Positions and sizes are illustrated on the proposed front garden plan.
