MATURE SYCAMORE T4 HAS LOST THE TOP OF ITS CROWN SOME YEARS AGO AND AS A CONSEQUENCE HAS DEVELOPED A SIGNIFICANT CAVITY THROUGHOUT THE FULL HEIGHT OF THE TRUNK.

THE CAVITY IS EXPOSED AT SEVERAL POINTS AROUND THE BASE OF THE TRUNK.

SEVERAL MEDIUM SIZED LOMBS HAVE ALREADY BEEN LOST OVER RECENT YEARS, ONE OF WHICH HAS FALLEN INTO THE GARDEN OF AN ADJACENT PROPERTY (46 BOWDEN GROVE).

ALL BRANCH ARISING WILL BE CHIPPED AND LEFT WITHIN THE WOODLAND EDGE / SHELTER BELT TO HELP WITH BIODIVERSITY.
