Telephone call with Matthew Marsden & John Mahoney regarding the condition "This certificate only grants the operational development as described but does NOT grant any change of use of the building to residential use. A retrospective planning application will be required for the change of use of the first floor of the garage to a residential annex. Without this the change of use is still liable for enforcement action given it can't be evidenced it has been established for 10 years at the time of this application" attached to the granted CLEUD. Explanation was provided that the change of use of the garage roof space to a flat did not fall under the 4 year time period and a retrospective householder planning application for the change of use would be required as advised on the decision notice.
