Details of the pre-application advice received

Original proposal was for an extension of width 3300mm. We were advised that permission was unlikely to be granted if the extension was more than 2700mm wide. The current plan is for an extension of 2600mm to match the current width of the existing conservatory which will be replaced by the extension.

A proposed covered area between the front wall of the extension and the front boundary of the property was also indicated to be likely permitted.
