Morning Andrew,

Writing in response to your pre-application for the above address, I can confirm that the proposed dwelling would be situated on land designated as a housing policy area under the UDP and as Urban Fabric within the emergent Local Plan, as such the principle of development is considered acceptable.

The visual design of the proposal is also considered acceptable and appropriate to the area and street scene of Tinker Lane – the dormer being located at the rear of the property maintains the bungalow style of the street . However Highways DC have assessed the pre-application submission and do not consider the internal dimensions of the integral garage to meet the requisite standards stipulated in the SYDRG in terms of length. They request that the plans be amended accordingly to increase the length of the garage in line with the SYDRG or that another off-street parking space is provided alternatively.

Other consultees included planning policy, drainage and South Yorkshire Mining Advisory Service. No concerns were raised by these parties in relation to the proposal.
