Details of the pre-application advice received

The style of dormer we have proposed, a traditional pitched roof, is the preferred style of dormer. This matches the existing roof on the house. As standard for planning, materials for a dormer, should match the existing dwelling. Tiles to match the roof are preferred.

They have noted that the property is in a conservation area and the conservation officer has also made comment; he believes the dormer would be acceptable as there are already two dormers with flat roofs on the street. He further comments that the pitched roof dormer is nicer and a more appropriate design.

It was suggested that a brief heritage statement will be required (this has been produced), focusing on the historic nature of Prospect and how the terrace contributes to the wider conservation area
