Why do you consider that a Lawful Development Certificate should be granted for this proposal?

The proposal consists of a single-storey rear extension to an existing detached dwelling, with the developed area around the property not exceeding 50%, with a depth as measured from the existing rear wall of the property not exceeding 3.0m, with an eaves height of no greater than 3.0m as within 2.0m of the boundary and overall not exceeding 4.0m at any point.

The proposals do not include any new verandas, antennae, chimneys but do include alterations of the flue & soil pipe.

The alterations of the flue and soil pipe comply with Class G permitted development limitations & requirements.

There are no alterations to the existing roof of the existing property.

The property is not on designated land.

The materials proposed, red brick, are of a similar appearance to those of the current rear elevations, red brick.
