Andrew,

I have had a look at this and can advise the following:

The change to residential is not permitted development but, is in my view acceptable in principle given the building is located in the Housing Policy area on the UDP and Urban Fabric on the emerging Local Plan. I have also had no objections raised by internal consultees.

You will need to confirm that the internal and external spacing standards can be achieved in relation to room sizes and garden / amenity space. I am also concerned about the potential impact on privacy in relation to The Crofter at the rear. There is just 18m between this property and the PH and as it has windows in the side elevation there is a question in relation to overlooking between the two. This may be resolvable through internal layout changes or the use of obscure glazing or if the existing accommodation is already residential (I am not clear from the plans).
